Appendix #1

President's Report - 2019

CMBC saw another successful year, treading new ground with the new trail policy (no pun intended). We probably broke records in terms of building trail connectors, which has been a great way to enhance our existing trail network while we navigate the new processes for trail development that are in place. Scott Keeseey (our trail director) has review our inaugural trail boot camp, and the incredible number of volunteer hours that we have put in (and that's just what we tracked on Trailforks), so I don't think I need to repeat how amazing the support of our mountain bike community has been. Over the next year, we look forward to working with the City on streamlining the trail application process and continuing to maintain and improve our network.

We continued to hold some of our classic events, such as the Bicycle Garage Sale (led by Maude Craig), Gravity Skills camp, and King of the Canyon – now renamed Royalty of the Canyon thanks to Colin McCann, I am happy to say – and we had some revamped events such as our new evening skills clinics, courtesy of Christine Prescott and Guillaume Levesque.

Klondike Krankfest didn't turn out exactly as we had hoped or expected, but it brought us some lessons learned, and ultimately our nimble volunteer base was able to take a tough situation and turn it into a positive one. We went back to a grassroots, cross-country lap-style event that had a great mix of racing and fun. Thanks to Tim and Kirsten Hogan for stepping in to make that happen. 5+ Hours of Light also demonstrated how creative our volunteers can be, with a last-minute location switch from Biathlon to Wolf Creek Campground after some uncooperative weather conditions. The warming shelter that Colin and Jaylene set up was really epic, and everyone had a great day!

Dirt Girls continues to be our most popular club offering, with 140 female-identifying individuals coming out to ride on one or more of the 16 evenings offered between May and August. The average group size was 25 riders per night, with a range of 13 to 43 people showing up on any given night. We also had 18 different women volunteer to lead rides this year. Thanks again to Georgi Pearson for making sure we had ride leaders and locations lined up every week.

Christine has already presented our good financial standing for another year, and we have been able to save some contingency funding for an eventual financial review in a few years, as well as anticipated maintenance and repairs on our grooming equipment and trailer. We were really excited to also be able to donate \$3,000 to the Youth Achievement Centre for the Grey Mountain Dream Trail, and \$1,900 to Singletrack to Success, to support other trail projects and maintenance which our members benefit from.

Reporting on MOU activities for period November 1, 2018 through October 31, 2019:

Trail Maintenance

CMBC renewed its commitment to the maintenance of existing trails this year by making trail maintenance an intention in the planning and execution of events. In collaboration with CoW and WCCSC, CMBC developed and delivered a Trail Maintenance Bootcamp in late May. This event included theory and practical skills development over three evenings, and was attended by 26 volunteers.

CMBC also conducted trail maintenance events approximately 3x/month between May and September. Many of these events were simple 'ride and prune' evenings, led by two individuals who attended the bootcamp. Larger monthly maintenance events were also held, with the following trails receiving attention by work crews (often in collaboration with CoW trail crew):

- Hula Girl
- Hilarious
- Bypass Trail
- Blues Brother
- Sweet Dreams
- Quiller
- Mad to the Max

The TrailForks platform was promoted extensively by CMBC as the preferred location for recording trail work effort. This was accomplished through live demonstrations at events, and also on social media. To this end, the following hours were captured during this reporting period for the Whitehorse Region:

Trail Reports: 81

Attendance: 239 individuals

Event hours: 526

Total Volunteer person-hours: 4,333

Trail Development

Applications submitted for the following trails. These proposed trails varied in length, but were all submitted using the application form provided by CoW under the new 2019 Trail Development Policy. Current status or understanding is also provided:

- Gummy Bears (Mt. Mac): work not approved

Small connectors, or 'enhancements' (less than 500m) completed under dialogue and inspection with CoW:

- Rock Lobster (Mt. Mac): two enhancement sections, lower section work approximately 75% complete.
- Aunt Flow (Grey Mountain): inspected, but work not initiated
- Two short connectors on either end of Logan's Run trail on Mt. Mac;
- RIPURT connector on Grey Mountain

CMBC is looking forward to engaging with CoW to gain clarity and certainty around the trail development approval process, to ensure that our enthusiastic volunteer membership is empowered and enabled to contribute in an efficient and transparent manner.

Grooming

Winter biking (fat biking) continues to skyrocket in popularity in the Whitehorse area. Grooming was undertaken routinely by volunteers on the Mt. Mac, Grey Mtn, and Chadburn Lake Trail networks. Substantial volunteer effort is also going into innovation and fabrication of specialized grooming equipment by CMBC volunteer members.

Effort was not captured with TrailForks, but an estimate of 80 hours for Mt. Mac was provided by the lead groomer, and it is also estimated that a larger effort was put into the other two networks. TrailForks will be utilized more thoroughly for tracking volunteer grooming efforts this year.
